

Driving myself Crazy. She has taken on skiing and flyfishing also. Some of you may have read her book on flyfishing titled **I Don't Know Why I Swallowed the Fly**. We originally had her scheduled for our September meeting but had to reschedule. Seems that her trip to Bhutan and the Himalayas wasn't going to end in time! She has even fished the Amazon River. Her next adventure book, tentatively titled *Flyfishing for Piranha*, will be part of her discussion at the meeting. She told me that she would entertain us with topics of fly fishing for Piranha and night fishing for 800-pound catfish!!! This should be good.

Volunteers Needed

ODFW-STEP is looking for 2-3 volunteers to help plant willow cuttings on the Deschutes River just downstream from Spring River Road in Sunriver. Some willows are already established in this area, but there is still plenty of exposed stream bank that could benefit from willows taking hold.

The willow cuttings need to be planted deep enough so their roots reach water during very low flows, but high enough they won't be inundated during high flow. We will be experimenting with water jet stingers, which make a deep 6', small diameter hole to plant the cuttings, getting them deep enough to reach the water table.

Our goal is to plant a short section of the river with approximately 50 cuttings. We need volunteers to assist with running stingers and cutting willow whips.

Fly of the Month

The BH Estaz

A fly tied for fish, not angler

A few years back I studied up on light, translucence and how that intermingled with color and what is believed that fish actually see. A great place to start is a book titled How Fish Work by Thomas J. Sholseth. It is a super book on fish physiology with the angler in mind. Anyhow, this months fly is one of my creations (however, not very creative) from those studies. It went through its refinement period on the Crooked River, and today I have super fishing days with this fly on the Crooked, all reaches of the Deschutes and other non-spring creek waters. It has not performed near as well on the Metolius or the Fall Rivers. I have had limited success on lakes. This fly has accounted for my 5 largest fish on the Crooked River, the largest over 20 inches. You can start laughing now, but this fly seems to increase my average catch size by about 3 inches on every water it fishes well on. It seems to fish best in the Fall months when dead drifted and then swung cross current at the end of the drift.

I played with many other materials for this fly, usually I'm not that picky, but the body material listed here significantly out fished all the others I've tried. As I've said, it's not very creative, but more of a choice in general profile, material, and size to attract the fish not anglers which makes it an easy tie.

Hook: #12-14 3x long nymph

Thread: Black

Tail: Pheasant Filo Plume

Abdomen: Medium gold Estaz chenille trimmed

Thorax: Same as body but untrimmed

Head: Black nickel bead

Tie in a full tail the same length as hook shank. Tie in and wrap the Estaz chenille pulling the fibers back with each wrap so it is tight and full. Wrap all the way to the bead. Tie off. Trim the Estaz short along the abdomen with a slight taper to the thorax. Leave some long fibers in the thorax area for legs. That's it. Also tie some with a black marabou tail and a black Estaz body.
