US Fish & Wildlife Service in Central Oregon

Fisheries management in Central Oregon is jointly shared by many agencies including the Oregon

Department of Fish & Wildlife, the US Forest Service, the National Oceanic and Atmospheric Administration, and the US Fish & Wildlife Service. Bridget Moran is the Field Supervisor for the Bend USFWS office where she manages a team of biologists working on a variety of efforts in Central Oregon.

She will discuss water management issues in the Deschutes Basin, with a discussion about the Deschutes Basin Habitat Conservation Plan (DBHCP), the first few years of DBHCP's implementation, and its long-term goals for the Deschutes and Crooked Rivers.

Prior to joining the Bend office, Bridget managed a team of biologists and managers for the USFWS in Olympia, WA, doing similar Endangered Species Act-related conservation work. Before joining the USFWS, Bridget worked for the State of Washington for 13 years, primarily at the executive level on natural resource issues related to forestry, agriculture, aquatic land management and salmon recovery. Bridget has a Bachelor of Science degree in Microbiology from the University of California-Davis, and a Master of Science degree in Environmental Toxicology from the University of Wisconsin-Madison.



South Twin Lake

MAY 7, 2022

Directions

The Twin lakes outing is scheduled for Sunday May 8 (Mother's Day). I didn't realize that when I scheduled it, so I'm changing it to May 7. You can get to South Twin from Bend by taking highway 97 south, past Sunriver and take the Vandervert road (Cascades Highway) exit. Take a left on Century drive (Highway 42) which follows the Fall River. Follow the sign to Twin lakes resort and South Twin.

The Fishing

Plan to meet at the boat lunch at 9:00. I'll be in my blue Scadden pontoon boat. The lake is best fished by a small boat – No motors (gas or electric) are allowed. Please check the Members area: Fishing tips "How to" section on the COF website for how to best fish the lake. Jeff Perin, owner of Flyfishers Place in Sisters recently said on his Blog: "South Twin is fishing well on the edges with Damsel Nymphs and Leeches. Off the drop and in deeper water with Chironomids. If you have sonar, look for fish to be out in deeper water and dangle an ice cream cone or juju midge for them. On a type 7 full sink that is fun to do"

Lunch

South Twin Resort has a great outside restaurant. For those that are interested, lets plan to meet at the outside tables for lunch at the resort at 12:30. Ask the Hostess where COF are sitting.

Finally – Owyhee Outing

14 COF members traveled to the outing. The weather was a small factor and it continued to get better as the

trip progressed. The fishing was slower than recent years and the fish were also smaller, 9 -16" and a few reports of fish that were 20". A small zebra midge under an indicator was working the best. We finally found a great BWO hatch followed by a caddis hatch on our last evening. The fish, browns and rainbows, were up to 16" and the dry fly action was nonstop!

Oregon Could Learn a Lot From Arizona

The following is reprinted from Yancy Lind's submission to The Bulletin from March. I felt it was important for our club in Central Oregon to see how water issues are being handled in another desert state (Arizona), so I got Yancy's permission to run it here. Yancy noted that our own Frank Turek supplied a lot of this info, as he was actively involved in Arizona's process for many years. — TQ

The Bend Bulletin published my guest column (March 30, 2022), "Oregon could learn a lot from Arizona". You really should have a subscription, a local newspaper is critical to having a well-functioning local government, but if you don't, I've reproduced it below. My last column in the paper was about hope not being a plan for solving our water crisis. Today the paper ran two stories on water, one of which quoted a state official stating "I was hoping for a much better winter this year, a recovery". Last week I had an email exchange with a federal agency involved in controlling releases from Prineville Reservoir in the Crooked River asking about their plans. The response was they were waiting to see what happens during the remainder of the spring. Once again, hope is not a plan and right now we have no plan. Arizona does. Here's my column in today's (March 30) paper.

Oregon has been mismanaging water for decades. Our lakes, reservoirs, rivers, and streams as well as the fish and wildlife that depend on them are suffering. People are suffering too as wells dry up, food production and economic output is reduced, and recreational opportunities diminished. Surface water and groundwater are both declining. In Central Oregon, groundwater is of critical importance as it is the source of most of our lakes and rivers. As has been

noted, “surface water and groundwater are intimately connected despite all efforts by lawyers and judges to rule otherwise”.

Over 50 years ago, Arizona experienced dramatic groundwater declines. In response, the state passed the Groundwater Management Act in 1980, which was hailed as the most far-reaching groundwater management regulatory framework in the United States. The Act is complex, but the highlights are easy to understand. Most importantly, water in Arizona is understood to be a precious commodity and is treated as such, unlike in Oregon where water is considered free and until recently, plentiful.

Arizona’s 1980 Act requires that prior to approval, most new developments must secure a 100-year supply of water. This 100-year supply could come from groundwater that is recharged with recycled water, from the purchase of surface water rights, from a city with a 100-year supply, or from mandated water conservation measures. While this may seem onerous to new development, the enormous growth in Arizona since 1980 has proven otherwise. A similar requirement does not exist in Oregon where developers can build with little to no concern about long term water availability.

The Act also required that canals in management areas be lined to stop leakage and that irrigation systems be upgraded so that overall distribution losses do not exceed 10%. Landowners had to bear the expense of these upgrades.

In Oregon, water is supposed to be used beneficially and without waste. Unfortunately, these provisions have been ignored. In Arizona, beneficial use without waste is enforced economically. No one will bear the expense of lining a canal or upgrading their irrigation system if they will not make money on the use of the water. Contrast that to Central Oregon where taxpayers are paying for canal piping and most irrigators are “hobby farmers” who do not make a profit.

Most irrigators in Arizona are given an annual water allocation based on crops grown and the actual water required for those crops over the past 5 years. Water use is monitored and reported at the expense of the landowner. In Central Oregon, water is delivered based on an allocation established when the state was first settled, regardless of the current use of the water. Further, water use is largely unmonitored and unreported.

In the 40+ years since the passage of the Act, Arizona has continued to adapt water policies to meet the

needs of a growing population and heating planet. For example, water recycling and direct groundwater recharge are now widely used. A recharge and recovery accounting system was implemented to protect the rights of the storer and stored water credits can be traded. Water conservation is a focus for domestic, municipal, industrial, and agricultural users.

Arizona knows that more work must be done. Declining levels in the Colorado River, higher temperatures and reduced snowpack, drought contingency planning, water rights transfers, the potential hydrologic disconnect between groundwater withdrawal and recharge, continued groundwater declines in some areas, tribal water rights, and environmental needs are among issues that are actively being addressing. The point is that they are working on the problem. Oregon is not. Clearly, Oregon is not Arizona. We need to craft legislation specific to our needs, a process that will be contentious. Over 40 years ago, however, Arizona showed how thoughtful government can proactively address complex problems and enact lasting solutions. We need effective leadership that will do the same.

MIDGE EMERGER

Well some late snow and some rain that is forecast for the weeks ahead has given to some hope of having water until mid-summer. But things are still going to require greater care of our fish, playing them with care, not pulling them too fast through the water or having them out of the water for any length of time so that they can't breathe. These creatures are special and they deserve respect and the help they need to survive, for they give us their all every time they give us a tug.

Hope those who watched the Winter Tying with the CO Fly Tyers Guild and the BT's Fly Tying Fridays have learned some tips and tricks along with some great flies. It is great to see tyers from different parts of the country and those outside the US, demonstrate their talents.

The fly this month is, yes another midge, this one is an emerger that has been used for a while and it is a great one for spring and early mornings. Has parts from others that I have seen and together this one has a buzzer body and wing case that is red in color, which what naturals do have some times. Fish it dry and drifting with the water currents caused by the wind.

Materials:

Hook: Daiichi 1167 Klinkhamer Hook #16 or any light wire scud hook will work.

Thread: Veevus Black 16/0, or match the hatch.

Shuck: Tan and Red mixture of EP fibers or Poly yarn.

Body: Black tying thread.

Rib: Sulky Silver Metallic #145-8040, this is the thinnest Mylar I have found and it works great for very small ribs, and it comes in other colors.

Wing case: Red, Ep trigger fiber or poly yarn.

Hackle: Dun, 2 CDC feathers barbules wound in a dubbing loop as a hackle.

Head: Tying thread.

Tying directions:

1. Lock in your thread 1/3 of the hook length behind the eye, as you wrap back tye in the schuck and then the ribbing materials. Keep the wraps smooth as you wind back down the back of the hook. Leave at least ¼ in of the schuck hanging down, (cutting short when the fly is complete to 1/16 in.
2. Now color the rib material with a red marking pen.
3. Now bring the rib forward with about 6 to 7 even wraps and tye off at the tye in point. At this point you can coat the body with your favorite coating to protect the body and rib. Let this dry before going forward.
4. Now tye in the Red wing case like a small wing facing back over the body, trimming to about 3/16 in.
5. Build a base of thread for the CDC hackle. Make a dubbing loop hackle of about 1 in long, starting up against the wing and wrap forward to the just behind the eye, and tye it off.
6. Finish with a head of black thread.


